Your Excellencies Ambassadors, General officers, Distinguished participants, The Media, Ladies and Gentlemen,

Esteemed members of the CTSAMVM Board,

Good morning.

I extend warm greetings to all the members of the CTSAMVM Board and welcome you to the 52nd CTSAMVM Board Meeting. Thank you all for attending today's meeting, Honorable Board members. I encourage you to share your thoughts and insights during our discussions to help foster peace in South Sudan.

Our agenda will follow the sequence of; the Permanent Ceasefire and the implementation progress of the Permanent Ceasefire and Transitional Security Arrangements, updates on ongoing tasks and violation reports.

Excellencies, Ladies and Gentlemen,

On the Status of the Ceasefire

I address you, the Board members, with deep concerns about the current threat to the ceasefire agreement. The current reporting period is marked by a tense and volatile situation.. Most critical is the situation in Upper Nile State, with several reports of mobilization of forces and alleged aerial bombardments. In addition, Western Equatoria and Upper Nile state have also experienced violence. These clashes significantly affect the implementation of the already fragile ceasefire and cause immense suffering to the civilian population.

In the last Board meeting it was noted that there were signs of a possible outbreak of violence in Upper Nile State unless urgent remedial steps were undertaken. Rather than seizing the opportunity of dialogue and compromise, the situation in Nasir Upper Nile State has become the hotspot where political conflict is escalating into a full blown armed conflict. CTSAMVM strongly urges the signatory parties to step away from the path of violence, respect the R-ARCSS and seek the path to peace for all across the breadth of South Sudan.

In Nasir, Upper Nile State, there was a clash between the SSPDF and a group of armed civilians referred to as the White Army. This clash resulted in the displacement of the SSPDF from their garrison in Wechyar Adiew and, leading to numerous fatalities, including that of an SSPDF General Officer, soldiers, a member of a UNMISS evacuation crew, and unverified civilians.

In the wake of the Nasir incident, a series of arrests targeting high-ranking Government officials and General Officers in Juba followed, along with confirmation of foreign troop deployment by the South Sudan Minister of Information. These activities have caused worry among many stakeholders of the R-ARCSS. CTSAMVM urges the signatory parties involved to exercise the highest level of restraint during this volatile period and extends its condolences to the families of all those who lost their lives. We again urge for a leveled ground for all actors founded on mutual trust. Compromise and dialogue should be the way forward. The prevailing violent confrontations have been broadly condemned by the international community and CTSAMVM reiterates the condemnation and concern as expressed by the IGAD Executive Secretary, IGAD ambassadors in Juba, the RJMEC and the United Nations. We call upon all involved parties to cease hostilities immediately and ensure that calm is promptly restored in the affected areas.

On NAS Activities

In Central Equatoria, suspected NAS elements ambushed civilians, looted properties, and burned a vehicle in Kajokeji County. They also attacked an SSPDF unit in Lewolo Payam, resulting in injuries and fatalities. CTSAMVM condemns these actions by NAS and reminds them that they are accountable for their actions, as stipulated in Article 5 (Protection of Civilians) of the CoHA 2017.

Rape by uniformed personnel

Rape reports involving members of signatory parties had diminished over the years. However, in February 2025, an incident occurred in Kuanya Payam of Wau County where uniformed soldiers raped a woman. A case has now been opened with the Wau North Police. CTSAMVM condemns these acts and reminds the signatory parties that incidents like these are a violation of the R-ARCSS.

Excellencies, Ladies and Gentlemen,

Violation Report

Today, there are two violation reports for discussion. The first concerns an alleged attack on the Ri Rangu SPLMA-IO Assembly Area on February 12, 2025, by the SSPDF, while the second report addresses allegations of civilian displacement and detention by forces allied to the SSPDF in Mukaya Payam of Lainya County. These reports have already been reviewed at both the Joint Monitoring and Coordination office and the CTSAMVM Technical Committee.

On CTSAMVM Activities

CTSAMVM has participated in several activities to support its mandate during this reporting period.

On March 10, I, along with IGAD Special Envoy to South Sudan Ambassador Ismail Wais and RJMEC Interim Chairperson Amb Maj Gen (Rtd) George Owinow, met with the Chairperson of the National Transitional Committee (NTC), Gen. Kuol Manyang, to discuss the progress and challenges in implementing the security provisions of the R-ARCSS, particularly the graduation and deployment of the Necessary Unified Forces, disarmament, and mechanisms to address ongoing security concerns. The meeting emphasized the urgent need for genuine commitment from all stakeholders with regards to the Revitalized Agreement. Peace and stability in South Sudan will happen if you, the parties, make it happen.

Again on March 11, I met with the Chief of Defense Forces of the SSPDF, General Paul Majok, to discuss the country's security concerns amid ongoing clashes in various states. Our conversation focused on the recent outbreaks of violence and the urgent need for measures to uphold the ceasefire agreement and de-escalate tensions. Since this, unfortunately, the security situation has become even more serious.

On a more positive note, CTSAMVM, through its Gender Cluster, hosted a one-day workshop to celebrate International Women's Day on that same day. The theme for this year was "Accelerate Action: Empowering Women and Girls to Promote Safety and a Healthy Environment." This theme aligns closely with the fundamental principles of peace, security, and inclusive development, which are core values guiding the work of CTSAMVM.

On the 12 March 2025, I attended the 43rd Extraordinary Summit of the IGAD Assembly of Heads of State and Government, held virtually, to discuss the situation in South Sudan. During this summit, it was decided that CTSAMVM would conduct an investigation into the clashes in Nasir and the attack on a UN helicopter. The goal is to ascertain the facts and ensure accountability for any violations. The investigation process has already started. But, as we all realize, the security situation in the Nasir area has since greatly worsened. We will regardless move forward with this investigation, and urge members of signatory parties to offer support to access this and other scenes of investigations.

Thank you all for your presence and your ongoing dedication to the objectives of CTSAMVM. Let us work together to ensure a productive meeting.
